AWIC offers free [3Rs \(replacement, reduction, refinement\) alternatives](#) literature searching services to help determine if alternatives can be incorporated into an animal use protocol and/or whether the protocol unnecessarily duplicates previous research. Both areas of information must be submitted to the Institutional Animal Care and Use Committee as required by the Animal Welfare Act (AWA) Regulations (*9 C.F.R. 2.31 (d)(ii-iii) (2022)*).

All individuals requesting a literature search from AWIC should complete and submit this form to [awic@usda.gov](mailto:awic@usda.gov). All requests remain confidential and are **NOT** shared with anyone outside of the AWIC team.

10. Will animals be euthanized at any point during the study or after study completion? If so, how will they be euthanized?
